

Non-AHP Specialty Provider Services Covered at the AHP/Tier 1 Benefit Level

The 2017 University Health Care Plans include a three-tier network. Under the plans, you have the choice to see health care providers within the Aetna and Excellus national networks, outside their networks or to receive services from a provider within the AHP network (a subset of Aetna's and Excellus' national networks). Tier 1 (Accountable Health Partners' network) provides for lower copays, deductibles, coinsurance and out-of-pocket maximums than under Tier 2 or Tier 3 for covered services. In addition, certain covered services received from non-AHP providers within the Aetna or Excellus national network will be covered at the Tier 1 (AHP) cost sharing level. When you use an Aetna or Excellus national network provider (*based on the TPA you have selected*) with one of the specialties listed below, you will receive coverage as though you used a Tier 1 (AHP) network provider. Not all services are covered under Tier 1 (Accountable Health Partners' network). Only certain services are covered at the Tier 1 (AHP) cost sharing level based on overall plan utilization.

For oral and maxillofacial treatment services that are covered under the Health Care Plans, services provided by a provider with one of the following specialties will be covered at the Tier 1 (AHP cost sharing level): Endodontics, Dentistry, and Oral Surgery.
