### **TOMORROW: Behavioral Health Consultation Teleconference**

### **Universal Masking at UR Medicine, Rochester Regional**

As announced on today's call, UR Medicine and Rochester Regional will institute universal masking starting at 7:00 pm, tomorrow March 31st. For UR Medicine, all personnel within inpatient, urgent care, procedure and clinic locations will be required to wear a mask at all times. UR Medicine made the decision to mask their entire health care workforce as a preventive strategy for reducing inadvertent exposure.
