Dear Colleagues:

In order to provide updates on the evolving response and best practices related to the COVID-19 pandemic, AHP will be delivering brief, critical updates on an ongoing basis addressing important highlights and frequently asked questions.

### **New Pre-Procedure and Pre-Operative Testing Requirements at SMH**

Effective June 21, COVID tests will not be required for asymptomatic, fully vaccinated patients undergoing procedures or surgeries at any SMH facility or outpatient clinic. Patients with any symptoms that could point to possible COVID must still be tested. To review the specific guidance, click [here](#).

### **New J&J Vaccine Shelf Life Authorization**

On June 10, 2021, the FDA authorized an extension of the shelf life for the Johnson & Johnson's Janssen single-shot COVID-19 vaccine (J&J vaccine) from 3 months to 4.5 months (an additional six weeks). Click [here](#) to view the authorization.

Vaccine providers that have J&J vaccine in storage should:

- Visit <https://vaxcheck.jnj/> and enter the lot number to confirm the latest expiration dates of vaccine.
- Mark the vials and carton with the new date displayed.
- Update the date in the NYSIIS inventory module.

If you have vaccine in storage that expired prior to June 10, 2021, those vials should be disposed as medical waste and reported as wastage in NYSIIS. Click [here](#) to see NYSIIS wastage reporting guidance.

### **Behavioral Health Cost-Sharing: Excellus and MVP**

The NYS emergency regulation waiving cost-share for in-person, outpatient behavioral health services was allowed to expire on May 26, 2021. Consequently, MVP will no longer waive cost sharing for these visits for commercial members effective May 26, 2021. Read the MVP communication [here](#). ### **New Visitation Guidelines for COVID+ Patients at SMH**

Effective June 28th, Strong Memorial Hospital will allow visitors ages 12 to 17 on an exception basis, but keep the general guideline that visitors should be 18 years of age or older with the following limitations:

- Only two designated visitors throughout the patient's stay, and only one allowed at the bedside at a time, for up to four hours.
- Visitors must wear PPE for the duration of the visit and will not be allowed to come and go from the hospital during their visit time.
- Visitors will be escorted to the lobby and out of the hospital at the end of a visit to prevent risk of transmission to others.

Strong Memorial Hospital will continue to provide, and strongly encourage, virtual visits for COVID-positive patients due to the risk of transmission from in-person contact. UR Medicine

### You Can Do It: COVID Vaccination in the Primary Care Setting

The data doesn't lie: PCPs can help overcome vaccine hesitancy by agreeing to administer COVID vaccine within their practices. According to a recent study, three out of 10 vaccine-hesitant adults would accept vaccination if offered by their PCP.

Don't believe the early hype: Offering COVID vaccination at your practice is actually much easier than you may think. Some things to consider:

- **Believe that since vaccine is available everywhere, your practice doesn't need to vaccinate?** The issues isn't access, it's overcoming hesitancy! There are many patients who can be persuaded to be vaccinated by their trusted PCP.
- **Heard that ordering vaccine supply from NYS is onerous?** Practices in Monroe County can have vaccine redistributed to them from the Monroe County Department of Public Health. Read more [here](#). Providers in other counties can be connected to [Jackie Lyttle](#) at the S2AY Rural Health Network to coordinate redistribution from your local health department.
- **Heard that storing vaccine is a headache?** Not really: requirements around transport, storage, and handling have loosened considerably.
- **Not enough nursing or other staff to handle a vaccination effort?** The United Way has volunteers available, including clinicians, to staff your vaccination clinics. These volunteers are already working successfully in several area private practices supporting their vaccination efforts. Contact [Kim Povec](#) for more information.
- **Don't think you have the time to develop and stand up a new workflow?** There are resources for workflow development, so you won't have to start from scratch.
- **Worried that you won't have enough patients willing to be vaccinated?** Don't be: you can be allocated a very small number of doses to get started.
- **Afraid of the consequences for wasting a dose?** Old news! The state's latest guidance around wastage can be summarized as, "do your best to use every dose, but not at the expense of missing an opportunity to vaccinate a willing patient."

### Convinced? Here's how to get started:

**Step #1: Enroll in the NYS COVID-19 Vaccination Program and obtain a COVID PIN.** Enrolling does not obligate the practice to administer the COVID vaccine, so practices are encouraged to enroll even if they are not certain. **Step #2: Determine what resources you may need to begin vaccination.** If you are in Monroe County, contact [Kathy Hiltunen](#) at the Monroe County Department of Public Health for guidance related to vaccine storage, handling, workflow development, etc. Outside of Monroe County, email [Jackie Lyttle](#) from S2AY Rural Health Network to be connected with local resources that can assist you.

**Step #3: Obtain a supply of vaccine.** If your practice is located in Monroe County you can quickly be allocated a vaccine supply from MCDPH. Click [here](#) to read the FAQs about requesting and

obtaining a vaccine allocation. Primary care practices located outside of Monroe County can email [Jackie Lyttle](#) from S2AY Rural Health Network to coordinate redistribution from your local health department.

We continue to partner with Dr. Mendoza and County Health Department officials on preparedness and response protocols and will convey information as it becomes available.
