In order to provide updates on the evolving response and best practices related to the COVID-19 pandemic, AHP will be delivering brief, critical updates on an ongoing basis addressing important highlights and frequently asked questions.

Updated Return to School Guidance Not Yet Available

During our call last week we had anticipated having updated return-to-school guidance to share with you by today. However, due to the recent changes in CDC isolation/quarantine guidelines and the prevalence of the omicron variant in the region, these guidelines and algorithms are again having to be reworked. Monroe County is working on these as we speak and is in communication with the surrounding Finger Lakes counties, so we hope to have updates to share by week's end.

Since we do not have this information yet and no other pressing information to share at this time, we decided to cancel the noon call for today and will update everyone via email distribution as soon as we have firm updates on plans for next week.

Our apologies for the course reversal, but as everyone has become all too aware, this is a rapidly changing situation and we want to make sure we are providing the most correct and actionable information possible and make most efficient utilization of your time!

Prescribing COVID Oral Agents
