Pfizer COVID-19 Vaccine Ordering Guidance for Children 6 Months – 4 Years Old
February 9, 2022

ALERT – Pfizer COVID-19 Vaccine for ages 6 months through 4 years Pre-Orders Open NOW!!

An Emergency Use Authorization (EUA) application for the Pfizer-BioNTech vaccine for children 6 months through 4 years old has been submitted to the FDA. Data were submitted for two doses of what is anticipated to be a three-dose series. The authorization is a multi-step clinical and regulatory process, and **no vaccine can be administered until the final recommendation is issued by the CDC Director, Dr. Walensky**. In preparation, this guidance includes details about the anticipated Pfizer-BioNTech pediatric product for ages 6 months through 4 years.

Providers in New York City should follow instructions from NYCDOHMH and CIR.

Pharmacy providers enrolled in the Federal Retail Pharmacy Program should follow instructions from CDC.

Anticipated timeline:

1. The Vaccines and Related Biological Products Advisory Committee (VRBPAC) (FDA's advisory group) is scheduled to meet on February 15, 2022.
2. FDA regulatory action/EUA issued (shipment of pre-ordered vaccine could commence)
3. The Advisory Committee on Immunization Practices (ACIP) (CDC's advisory group) is expected to meet within several days of VRBPAC; the meeting will be posted here once scheduled: <https://www.cdc.gov/vaccines/acip/index.html>
4. NYS Clinical Advisory Task Force deliberates.
5. CDC recommendation via Dr. Walensky statement – **until this final recommendation is issued by the CDC Director, no pediatric vaccine can be administered to children 6 months through 4 years old.**
6. Clinical considerations to support operations are released.

Important Information about Pfizer-BioNTech COVID-19 Vaccine for children 6 months through 4 years old

- The Pfizer-BioNTech vaccine for 6 months through 4 years ships at -80°C, like all current Pfizer COVID-19 vaccines, and has a similar product configuration to the 5–11 year old vaccine, but with a **different color cap (maroon), different dose (3 micrograms/0.2mL), different amount of diluent added (2.2mL), and a new national drug code (NDC).**
- The vials will have a maroon cap and vial labels with a maroon border.
- The current products for adults, adolescents, and children ages 5-11 years **CANNOT** be used in children 6 months through 4 years.
- The packaging configuration will be 10-dose vials in cartons of 10 vials each (100 doses total) pending FDA authorization. The product will be delivered in a single-use product shipper at -80°C (on dry ice).
- **The minimum order quantity will be 100 doses.**

- Once the product arrives at the provider site, it **can be stored for up to 10 weeks at refrigerated temperatures of 2 to 8°C and up to 9 months at ultra-cold temperatures of -90 to -60°C.** **NOTE: No standard freezer storage is approved for this formulation.**
- Once a vial is reconstituted, all 10 doses must be used within 12 hours.
- Responsible wastage policies remain in effect. Providers should plan to minimize waste to the best of their ability but should not miss the opportunity to vaccinate a willing individual, even if it results in other wasted doses.
- Pfizer COVID-19 pediatric vaccine for 6 months through 4 years will require diluent. The diluent will be provided with ancillary supplies. **NOTE – reconstitution of the product for use in 6 months through 4 year olds uses a different volume of diluent (2.2 mL) than the pediatric 5-11 (orange cap) product (1.3 mL).**

^b Diluent: Sterile 0.9% Sodium Chloride Injection, USP. Do not use bacteriostatic 0.9% Sodium Chloride Injection or any other diluent.

^c Regardless of storage condition, vaccines should not be used after 9 months from the date of manufacture printed on the vial and cartons.

^d The vaccine is currently under emergency use authorization review by the Food and Drug Administration (FDA) for children 6 months through 4 years old.

Important Ordering Information

- To ensure efficient rollout of this vaccine supply, CDC is allowing pre-ordering of vaccines. Providers may begin to place their Pfizer-BioNTech COVID-19 vaccine orders for ages 6m-4y in NYSIS on **Wednesday, February 9, 2022.**
- Place your pre-orders for Pfizer-BioNTech COVID-19 vaccine for ages 6m-4y separate from other vaccine orders.
- Shipment of Pfizer-BioNTech COVID-19 vaccine for ages 6m-4y is planned to begin once FDA issues the EUA. However, vaccine administration can only begin following the CDC recommendation.

- It is anticipated that orders entered in NYSIIS on February 9th and 10th will deliver on Monday, February 21st. **Because this is President's Day (federal holiday), NYS will only approve your order for potential delivery that day if you enter an order note in NYSIIS stating "will be available for delivery 2/21."** If this order note is not entered on orders placed prior to February 11th, we will hold on submitting your order to CDC until after February 11th to ensure delivery after February 21st.
- Orders placed after February 10th should begin delivering February 22nd (see anticipated Order and Delivery Timeline below).
- Minimum ordering quantities will be 100 doses (10 vials). Providers are strongly encouraged to directly order this product rather than rely on redistribution.
- New York State has a limited quantity of doses available for ordering in the pre-order period. Please limit your order to what you anticipate administering in the first 3 weeks after approval (or minimum order quantity, whichever is larger).
- There is no limit on frequency of orders placed after the pre-order period (i.e. after 2/24) and will take approximately one week to deliver.

Step 2: Enter the number of doses **in 100-dose increments** in the Doses Ordered box. Pfizer-BioNTech COVID-19 vaccine for 6m-4y must be entered under the NDC 59267-0078-04 highlighted above.

Note: If you enter an amount that is not in 100 dose increments NYSIIS will round up to the next multiple upon saving.

If you are placing a large order, it is always helpful to add Order Notes with information about your vaccination plans (text box located above the Orderable Vaccine boxes).

Step 3: Check the Inventory Verified box.

Step 4: Click Save & Submit.

Note: If you only click Save button, your order will not be submitted to the Vaccine Program for review.
